



# San Diego YC – Royal Vancouver YC Challenge Notice of Race

August 10 & 12, 2018

#### 1 Rules

- 1.1 The Organizing Authority (OA) is the Royal Vancouver Yacht Club (RVYC).
- 1.2 The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS), including Appendix D Team Racing Rules, and Appendix L Addendum B.
- 1.3 In the event of conflict between any of the above rules and/or regulations and the sailing instructions (SI), the SI shall prevail.

#### 2 Boats

Elliott 6m boats will be provided by the OA. The OA will make every reasonable attempt to equalize the boats. Standing rigging shall not be adjusted, except by permission and direction of the OA.

### 3 Team

The event will be sailed by teams from San Diego YC and Royal Vancouver YC. Each team will consist of nine people sailing three boats for each team.

# 4 Advertising

A boat and her crew shall comply with ISAF Regulation 20, Advertising Code.

## 5 Eligibility and Entry

5.1 Each crew member shall be a member in good standing of their respective club.

## 6 Registration

6.1 Registration may be completed on Friday August 10, 2018 in the Star and Dragon restaurant from 1000 to 1100 hours.

# 7 Fees

There are no fees for the regatta.

## 8 Schedule

- 8.1 August 10, 1000 to 1100 hours -- registration.
- 8.2 August 10 Fleet Racing, first warning at 1200 hours. Five races are scheduled.
- 8.3 August 12 Team Racing, first warning at 1100 hours. Nine races are scheduled.
- 8.4 No warning signal will be displayed after 1600 hours.

## 9 Sailing Instructions

The sailing instructions will be available after 09:00 on August 10, 2018 at the regatta office located in the sailing director's office on the dry dock.

#### 10 The Courses

For fleet racing, the courses will be windward-leeward, with target times of 30 minutes. For team racing, the course will be a box course with marks to starboard, with target times of 20 minutes.

# 11 Scoring

- 11.1 Fleet racing on Friday will be scored in accordance with Appendix A.
- 11.2 One race will constitute a series.
- 11.3 When fewer than three races have been completed, a boat's series score will be the total of her races. When three of more races have been completed, a boat's series score will be the total of her races excluding her worst score.
- 11.4 Team Racing on Sunday will be scored in accordance with Appendix D, except as modified by the sailing instructions.

#### 12 Protests

When practicable, protests will be heard on the water, as modified by the sailing instructions.

#### 13 Radio Communication

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones and other similar electronic devices.

# 14 Disclaimer of Liability

Competitors participate in the regatta entirely at their own risk. See RRS, rule 4, Decision to Race. The Organizing Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
